- Executive Session was held prior to the start of the meeting to discuss personnel hiring.

  - William Morey came to discuss his complaints about difficulties receiving a permit for storage units and a store he wishes to operate. For a storage unit to be approved they need a zoning permit and construction permit for 3 walls. To operate a store the process is more detailed. UCC & Zoning permits and up to 6 stamped Engineer architect copies are required to be turned into L. Frace to begin the process.
  - William Morey also questioned if the Township has plans for the downed trees which got pushed on his property after the storm on 26JUN2024. Road Master S. Rauch said unfortunately the Township has a lot of tree issues and this is a work in progress.
  - Vickie Harding was concerned about clearing the Creek of Trees near 7<sup>th,</sup> Dickson & New Road. Since the complaint the tree has been cut up and made small enough so it will flow down the creek.
