#### Police Report

- 7th Level Phone System Upgrade
  - The total cost of the new equipment would be +/-\$10,260 not to exceed \$12,600, reducing our monthly phone bill to \$135.45. In addition, we will need to purchase a new rack to properly run wiring that will also hold an additional switch. We currently pay Breezeline a monthly phone bill of +/-\$411.00, saving us on average +/-\$275.55 monthly. This will be paid for with the ARP fund.
    - M. Sitler made a motion to proceed with the 7th Level Phone System Upgrade. J. Gallagher seconded the motion. Motion passed 5-0.
- Website Our website went down unexpectedly. Our host currently is FATCOW. When the website was built, a program we used was called Weebly. FATCOW is in the process of doing away with their support of Weebly. Although our website is currently up and running this will be for a limited time. We will need to consider rebuilding our website using WordPress or using a Web builder.

#### Solicitors Report

- Blight Property Bid after further review according to the Inheritance Tax Division of the Department of Revenue said we must use the assessed value of the property at the time the previous owner passed away. The assessed value of the property is \$61,655.75. The Dept. of Revenue allowed us to take off deductions from the assessed value but wanted tax at 4.5% on \$60,601.00 which was \$2,727.05 plus interest and penalties from the date the previous owner passed away which brings the total to \$4,939.70 and counting. The bid for the Blight property of \$5,000 could be accepted under the condition the buyer is willing to pay the inheritance tax in addition to the bid offered to remove the lien on the property.
- Breezeline Cable Franchise Agreement it is time to renew the 10-year agreement.
  The solicitor gave us the ok to move forward with renewal.
