 T. Frace stated that communication is available with all of Luzerne County via the analog lines but not on the digital side yet. Digital communications between municipalities would need to be done through Motorola and there would be some additional costs to municipalities to establish this.
 - T. Frace stated that Airiam completed the IT penetration test. There was a minor issue related to a printer vulnerability that is being resolved. He also noted that the server is maxed out and will likely need to be replaced. Airiam provided a ballpark figure to T. Frace. It was suggested to utilize the remaining ARP funds allocated for the township's technological improvements for this. It would likely be actioned sometime in the first quarter of next year.
